EARNEST MONEY SUBMISSION OPTIONS

IMPORTANT: If closing is to occur in less than 15 days of earnest money submission, payment must be submitted in the form of a cashier's/certified check or wire.

INDIANA GOOD FUNDS LAW

EARNEST MONEY IN EXCESS OF \$10,000 must be submitted via wire transfer.

Title companies can only accept digital payments via ACH transfers for any incoming funds using vendors which utilize a system that does not have a pull back or reversal option, ensuring the funds are unconditionally held and irrevocably credited.

SUBMISSION OPTIONS

WIRE TRANSFER	REQUIRED: Name, cell phone number, and email address of the person sending wire, along with the property address. We will initiate a text and email from CertifiD, a secure portal, which will allow you to send and receive sensitive banking information.	ACH transfers sent from a buyer or bank directly are not permitted.

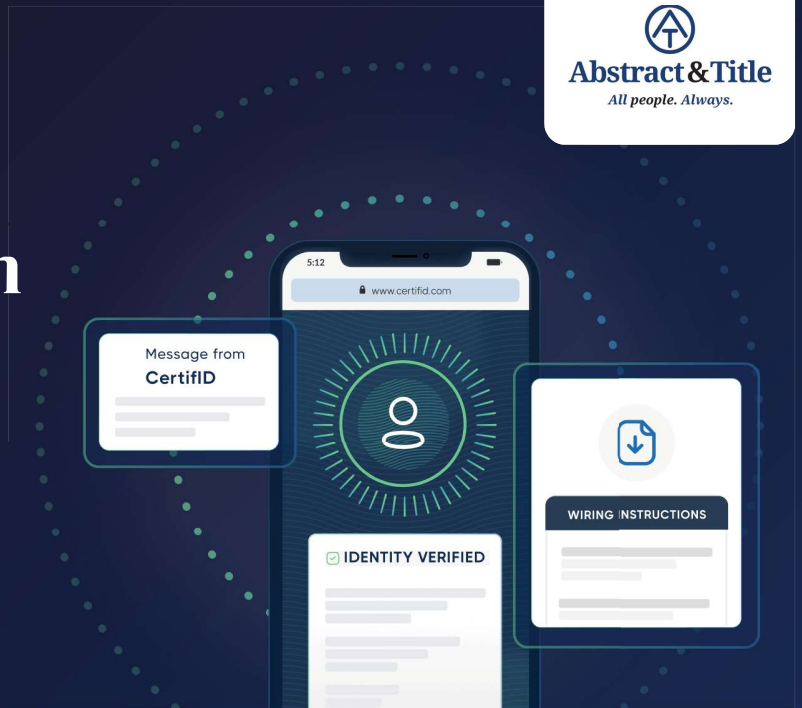

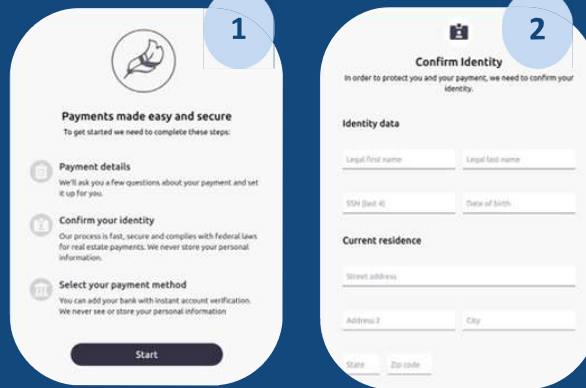

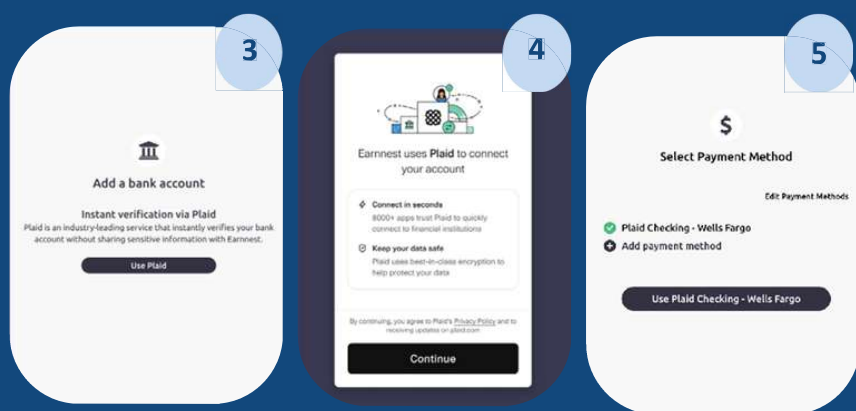
Payment overview + confirm identity

2. Provide the information needed to confirm your identity.



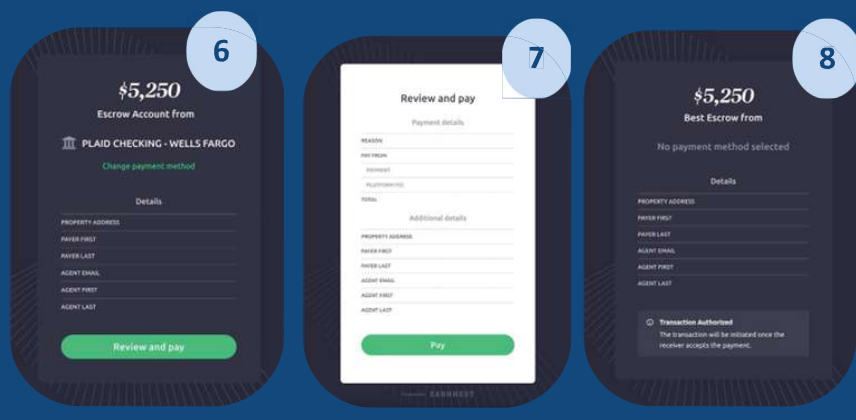
Connect your bank + choose account
